

ORDINANCE NO: 8-27-18-1 FORMERLY 08-06-07-1

AN ORDINANCE PRESCRIBING AND FIXING LICENSE FOR THE PRIVILEGE OF CARRYING ON BUSINESSES, OCCUPATIONS AND PROFESSIONS IN THE CITY OF EAST BREWTON, ALABAMA, AND WITHIN THE POLICE JURISDICTION THEREOF FOR THE CALENDAR YEAR 2019 AND FOR EACH CALENDAR YEAR THEREAFTER.

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF EAST BREWTON, ALABAMA AS FOLLOWS:

That Ordinance No. 11-15-96-2 heretofore adopted and approved on November 15, 1996, and was published in three (3) places within the City of East Brewton, Alabama, is hereby amended in words and figures as follows:

SECTION 1: That every person, firm, company, corporation, or association, who shall engage in any business, vocation, occupation, trade, or who shall exercise any privilege hereinafter described for which a license is required within the corporate limits or police jurisdiction of the City of East Brewton, Alabama, shall procure with the Clerk of the City of East Brewton, Alabama, a license and shall pay for the same the amounts hereinafter provided and in addition shall when required make such reports and give true statements of the gross amounts of business done upon which such license or privilege tax may be determined, and shall comply with the provisions of the ordinance.

SECTION 2: For every person, firm, company, corporation, or association, who shall engage in any business, vocation, occupation, profession, trade or who shall exercise any privilege hereinafter described for which a license is required within the corporate limits or police jurisdiction of the City of Est Brewton, Alabama, such person, firm, company, corporation, or association shall secure the following license tax for the year 2019 and each year thereafter, which said license taxes shall extend from the 1st day of January, 1997, the 31st day of December 2018, both inclusive, and each successive year thereafter until amended or appealed. All licenses and taxes shall become due on the 1st day of January and delinquent on the 31st day of January of each succeeding year hereafter.

SECTION 3: All businesses, trades, or professions done within the police jurisdiction of the City of East Brewton, Alabama, the amount of such licenses shall be one-half of the amount charged and collected as a license for like business, trade, or profession done or carried on within the corporate limits.

SECTION 4: That any provision of any ordinance to the contrary notwithstanding, all revenues derived in the police jurisdiction of the City of East Brewton from license taxes levied

by the City of East Brewton shall be used for the protection of the lives, health, and the property of the citizens and the maintenance of good order and quiet of the community and the preservation of public morals.

SECTION 5:

Utilities

221122. Electric Power Distribution

- (a) An amount equal to 3% of the gross revenue received by such company from the sale of electric current within the city during the preceding calendar year.
- (b) An amount equal to 1 ½ % of the gross revenues received during the preceding calendar year from the sale of electrical current to consumers, users or distributors residing or having a place of business outside the corporate city limits, but within the police jurisdiction of the city.

- (c) Liability, property damage, collision, theft and all other forms of insurance except life and fire: \$15.00 and in addition thereto \$1.00 on each \$100.00 and major fraction thereof of gross premiums received during the preceding year on policies issued in said year on property within or to citizens being in the city.
- (d) Bonding or surety company: \$15.00 and in addition thereto \$1.00 and each \$100.00 and major fraction thereof of gross premiums received during the preceding year on business written in said year upon risks within or for citizens living in the city.
- (e) Insurance Company which has not done business during the preceding year in the city or its police jurisdiction shall pay a license of \$70.00 in advance, and there shall be an adjustment at the expiration of a year on such license according to the schedule hereinabove specified.

State Law Reference-Authority as to licensing of insurance companies, Code of Alabama 1975, 11-51-120 and 11-151-123.

SECTION 6: The Mayor, Clerk or other license inspector may require sworn statements as to the amount of capital stock invested or the value of goods or stock or the amount of sales and receipts where the amount of the license is made to depend thereon: and it shall be unlawful for any person to knowingly or willfully make or exhibit any false written affidavit, certificate or statement as to the amount of stock on hand or amount of gross receipts business done or as to any other fact and to file same with the City Clerk for purpose of defrauding the City of East

Brewton by avoiding the payment of a license or for procuring a license for a less sum than is lawfully due by such person or his principal.

SECTION 7: In case any license as provided for in this ordinance is taken out after the first day of July of each current year, only one-half the license shall be charged and collected, except in cases providing for daily, weekly, or monthly license.

SECTION 8: No License shall be transferred without the consent of the council, and never more than once, and never from one business to another.

SECTION 9: The adoption of this schedule of license shall not abridge the right the City Council to change, alter, increase, or decrease any of the license at any time: nor shall it abridge the right of the city Council to require a license for any business, occupation, traffic, calling, or profession not included in this schedule.

SECTION 10: After delinquency in the payment of any license hereunder due, a citation thereof shall be served by the Chief of Police or License Inspector on the person, firm or corporation responsible for the payment of said license, for which a fee of \$25.00 will be collected, in addition to the amount of license and a penalty of 10% thereof for the delinquency.

SECTION 11: Any persons violating any of the provisions of this ordinance or doing any act made unlawful by the terms herein shall upon conviction in any case be fined not less than \$1.00 nor more than \$100.00 and may also be sentenced to hard labor for the City of East Brewton for not exceeding six (6) months, either or both, at the discretion of the Judge trying the case.

SECTION 12: No refund will be made on licenses unless the amount collected is in excess of the amount prescribed by this schedule.

SECTION 13: All ordinances or parts of ordinances in conflict with the provisions hereof, are hereby repealed, provided, however that special ordinances relating to gasoline taxes, beer and cigarette taxes, etc. not herein specifically repealed shall remain in full force and effect.

SECTION 14: If for any reason, by any cause, sentence, section, subsection, schedule, part of schedule or provision of this ordinance, or the application thereof to any person or nay circumstance, is held invalid or inoperative, the remainder of the ordinance and the application thereof to other persons or circumstances shall remain in full force and effect.

SECTION 15: The provisions of the above and foregoing amended schedule of license shall become effective at midnight, December 31, 2018.
